COMMUTER MEAL PLAN APPLICATION/AGREEMENT

The Commuter meal plan is for incoming and current Cedar Crest students who are commuting to campus. The Plan is available for either the fall or spring semester and does not include College vacation periods or the January and summer sessions. Meals are available at the start of the semester and include the first and last days thereof. Any remaining meals associated with the Plan at the end of the semester will be forfeited. Students wishing to extend the plan to a new semester must submit a new Agreement. Meals will not be valid after graduation. If this contract is void due to the student's withdrawal from the College, adjustments will be made in accordance with the College's Refund Policy as stated in the College Catalog. Students residing on campus should complete the meal agreement for residential students.

MEAL PLAN OPTIONS & FEES

Full payment for meal plan is due when application/agreement is submitted. Commuter Meal Plans must be purchased prior to the end of the first week of the fall and spring semester. The Meal Plan options and fees are as follows:

Weekly Plan

5 Meal Plan (\$500.00)

This meal plan offers commuter students 5 meals per week to be used at breakfast, lunch or dinner during the week as well as brunch and dinner during the weekend. Each Friday the plan resets with 5 new meals to be used the following week. Any meals that are not used within the designated time frame for a meal period are forfeited. This plan also includes \$50 flex dollars each semester.

Block Plans

25 Block Meal Plan (\$200.00)

50 Block Meal Plan (\$400.00)

150 Block Meal Plan (\$1,932.00)

Commuter students begin each semester with a block of 25, 50, or 150 meals. Meals may be used during any meal period during the semester. More than one meal can be used in a meal period with this option, so students can use this meal plan to pay for guests that accompany them in Campus Dining facilities. Block plans also include \$50 flex dollars each semester.

TERMS OF APPLICATION

Continued campus dining privileges under this contract are contingent upon compliance with College policies, procedures and regulations contained in, but not limited to, the Cedar Crest Catalog and Student Handbook. Failure to comply with the terms and conditions of the agreement will be considered a violation of this application and subject the student to a potential loss of Cedar Crest Dining privileges. In the event that a student fails to pay meal plan charges when due, the College may terminate this contract at any time. The student's official identification card will be used to gain access to the dining facilities. The dining plan is for the sole and exclusive use of the student who contracts for the service. Upon acceptance by the College, this agreement can't be voided except as outlined herein.

Commuter students who request a meal plan during one semester will NOT automatically receive the same plan the following semester. A new form and agreement must be submitted each semester. Changes to the meal plan are permitted only during the official dining plan change period which concludes at the end of the first week of each semester.
